Sub: - Approval to carryout "Heat Treatment" coming under Indian Boiler Regulations, 1950 and its latest amendments.

Gentlemen,

With reference to your letter No. PEIPL/VED/24-25/1739, dated 02-10-2024, on above subject and subsequent visit of competent person of this Directorate, to your works on **02-12-2024**, for verification of your competency, I have to inform you that, the same is found satisfactory. You are now provisionally permitted to carryout "Heat Treatment" coming under purview of Indian Boiler Regulation 1950, under the supervision of this Directorate, for the period up to **31.12.2025**, subject to the following conditions:

- 1. The report along with the graph of heat treatment for each job should be submitted directly or through your client for approval.
- 2. The chart along with report should give the particulars about name of the client, description of job (including thickness) material of the job, method adopted, date of heat treatment, job number, particulars such as i.e. starting time, rate of heating, soaking temperature and period rate of cooling, duly signed by your authorized technical person.
- 3. You should maintain a register showing details of heat treatment carried out giving the details of job description, client's name, material specification, date of heat treatment, cycle of heat treatment i.e. starting time of heat treatment, rate of heating soaking time, soaking period, cooling rate etc.
- 4. All sensors, thermocouples, controllers and recorders shall be properly maintained.
- 5. All recorders shall be periodically calibrated and copies of certificates should be submitted to this Directorate.
- 6. The Director reserves the right of withdrawal of approval without any prior notice, if quality and workmanship is not found satisfactory.
- 7. As per rule 152(3) of Maharashtra Boiler Rules 1962, any change in related staff should be immediately informed to this office.
